Proceedings of 20thDistrict Level Research-Extension Interface meet of Sundargarh District

The 20thDistrict Level Research-Extension Interface meeting of Sundargarh district was conducted under the Chairmanship of Prof. A.K. Mohanty, A.D.R. RRTTS, OUAT, Chipilima at 10.30 AM on 23.07.2019 in Conference Hall of KVK, Sundargarh-I. At the outset the Senior Scientist and Head, KVK Sundargarh-I welcomed the Chairman & members in the house and highlighted the action taken on recommendations of previous meeting and ongoing activities. A.D.R. RRTTS, Chipilima informed the house about the aim, objective and needs of RE meeting.

The highlights of the meeting:

- SSH KVK Sundargarh-1&II informed the progress of Action plan of Kharif to the house. SS&H, Sundargarh-I, Informed the house on progress of action plan of KVK 2019-20. Five numbers Of OFTs, on Varietal trial on pigeonpea (BRG-5, PRG-176and Richa-2000), Varietal trial on ragi (Jagulei, Arjun and Bhairabi), Varietal trial of drought tolerance rice varieties (DRR-42,DRR-44 & Swarna shreya) Varietal trial of Protein rich rice varieties(CRR-310 & CRR-311) and 3nos. of Front Line Demonstration of herbicide (bispyribac sodium in DSR, Demonstration of STRV of IRRI and Nutritional garden have been completed and also highlighted the delay of transplanting of rice due to deficit of rainfall also DSR and non-paddy crop of the District are severely affected.
- 2. DDA Sundargarh agreed with this and informed the house about details of Block-wise crop condition and out of 17 blocks 12 Blocks are severely affected. He also told, if this situation will be continued for a week then it leads severe drought and also informed the house about selection of farmers about distribution of battery operated sprayer.

- DDH –Give information about different schemes of Horticulture department on Fruit plants under NHM, Low cost Mushroom production unit, Pusa Zero energy cool chamber, Cold room with subsidy.
- DFO –informed the house about collaborative progress in Vana Surakhya Samiti area with horticulture(Plantation mango), KVK (CFLD on Greengram and Nutritional gardening and Mushroom production)
- AFO Informed the house about different schemes of Fisheries department and that excavation of pond with 50% subsidise rate for fish farming also highlighted about Jayanti Rohu cultivation.
- 6. House discussed about the success of Samarendra Kisan, floriculture (Marigold) entrepreneur, Badagaon block.
- 7. Senior scientist & Head, Sundargarh-1 proposed to develop a monthly agricultural advisory bulletin covering important crops and commodities of the district, which will be printed and send to every FIAC for farming community. PD ATMA agreed to give financial support for preparing News bulletin
- 8. Chairman advised the SS& Head to mention the nutritional value of different crops in Nutritional garden, analysis the nutritional intake of farm families in a display board. He suggested to mention the income and expenditure of all demo units in display board and task of News bulletin will briefly discussed in Next RE Meeting He also expressed his thanks to all the members for nice discussion and collaboration.

The meeting ended at 2:30 PM with vote of thanks by Dr (Mrs.) Manasi Bhol, Senior Scientist and Head, KVK, Sundargarh-II to the Chair and all members.
